Natural Resource Damage Assessment (NRDA) funds focused on Early Restoration and Environmental Assessments


National Fish and Wildlife Foundation (NFWF) – funds focused on protect and restore the Gulf Coast's natural resources and diverse wildlife

Resources and Ecosystems Sustainability, Tourist Opportunities, and Revived Economies of the Gulf Coast States Act (RESTORE Act) – funds must be used for eligible activities

#### Allocation of Gulf Coast Restoration Trust Fund



# **RESTORE Act Multiyear Implementation Plan (MYIP)**

## **RESTORE Eligible Activities**











Restoration and protection of natural resources, ecosystems , fisheries, marine and wildlife habitats, beaches, and coastal wetlands

Infrastructure projects benefitting the economy or ecological resources, including port infrastructure Coastal flood protection and related infrastructure; Improvements to or on State parks located in coastal areas

Mitigation of damage to fish, wildlife, and natural resources Workforce development and job training; Planning assistance; and the administrative costs of complying with this subsection
