The Tualatin River Watershed in northwestern Oregon is home to one of the country's largest and most successful landscape conservation programs — *Tree for All*. Tree for All partners restore about 10 river miles annually across urban and rural landscapes. Since 2005 this program has found a home for more than 15 million native plants and with this success comes the need for long-term stewardship of more than 700 projects and 150 river miles of restoration.

A few of your essential functions will include:

- Oversight and development of community-based stewardship programs
- Development of transformational partnerships that support landscape conservation
